Other honorary guest included, Dr. Kurt Klinepeter, Horizons Medical Director from 1990 – 2022, Tom Byrd, Horizons former CEO of 30 years, and Horizons residents and their families.

Richard Anderson publicly announced the ARPA funding we received from Forsyth County as well as the Horizons Housing Initiative to our Community. There was tremendous enthusiasm and support for this exciting next chapter in Horizons' history.


